

Terms and Conditions for The Nation on Trial

1. By entering The Nation on Trial the participant will be deemed to have read and understood these rules and instructions and be bound by them.
2. All entrants must complete the registration page on www.nationontrial.org and post at least one accurate rowing time for 2k on the results page of the website. The Nation on Trial reserves the right to ask for this to be verified by an independent coach/trainer.
3. Any entry which is incomplete, illegible, late or otherwise does not otherwise comply with the rules may be deemed invalid at the sole discretion of The Nation on Trial.
4. Entries must be received by midnight (GMT) on Wednesday 29 February 2012. No entries received after this time will be deemed valid.
5. There will be two prize winners – one from participants aged 25 and over (“Seniors”) and the other from participants aged under 25 (“Juniors”).
6. The prize for both the Seniors and the Juniors is a trip for two to the GB Rowing Team Senior Trials at Eton Dorney on March 11 including travel and accommodation costs up to £200.
7. If the Junior winner is under the age of 18 he or she must be accompanied by a parent or other responsible adult.
8. The winners will be chosen at random from all qualifying participants in The Nation on Trial (regardless of their time or ability) by an independent person whose decision is final, and no correspondence will be entered into. The winners will be notified as soon as possible after February 29.
9. There are no cash alternatives to the prize. No substitute prizes will be offered, except where the original prize is no longer available. In the event that the GB Rowing Team Senior Trials have to be cancelled for whatever reason a suitable alternative prize will be offered at the GB Rowing Team’s sole discretion.
10. Individuals from outside Great Britain can enter The Nation on Trial, although they are not eligible for the prize draw.
11. British Rowing and the GB Rowing Team will collect and store your personal information to process your entry and provide updates on The Nation on Trial and the event partners. We will not pass your details onto any other third parties.
12. No liability or responsibility for any loss, injury or damage which may be suffered or incurred as a result of, or arising from, any participation in The Nation on Trial

or the prize offered by The Nation on Trial, and acceptance of and participation in The Nation on Trial and the prize will be entirely at the winners' risk. The GB Rowing Team's decision on all matters affecting this competition is final.
